The term "Cigna Dental Care® Prepaid Plan" is used to refer to product designs that may differ by state of residence of enrollee, including but not limited to, prepaid plans, managed care plans (including Dental HMO plans), and plans with open access features. The Cigna Dental Care Prepaid plan for the State of Tennessee Group Insurance Plan is not available in every state. Currently it is not available in Alaska, Idaho, Maine, Montana, New Hampshire, New Mexico, North Dakota, Puerto Rico, South Dakota, Vermont, West Virginia, Wyoming, and US Virgin Islands. There are no out-of-network benefits, except for emergencies or where required by law.

2. Review the enclosed materials for more information about the services covered under the Cigna Dental Care plan, including a listing of plan exclusions and limitations. For complete details about the services covered under your plan, review your plan documents.

3. A benefit is paid for covered out-of-network emergency dental care. Certain states mandate coverage for dental care received out-of-network. For example, in Minnesota, the plan will pay 50% of the value of your network benefit for covered out-of-network services. In Oklahoma, the plan will pay the same amount it pays network dentists for covered out-of-network services. You are responsible for any charges not covered by the plan. Other states may have similar mandates. Refer to your plan documents for cost and coverage details.

4. Referrals are not required for network orthodontists or pediatric dentists.

Dentists who participate in Cigna's network are independent contractors solely responsible for the treatment provided to their patients. Dentists are not agents of Cigna.
