## Instructions: Application for Coin-Operated Amusement Machine License and Decals

### General Information

Any person engaged in the business of providing coin-operated amusement machines for public use is required to file an application with the Department of Revenue on or before June 1st of each year for a license to engage in such business. Any person commencing business subsequent to July 1st shall apply for such license prior to the commencement of business. This license will expire on June 30th of each year.

For coin-operated amusement machine license and/or decal renewals or amendments, please use form VID 215 Renewal for Coin-Operated Amusement Machine License and Decals.

Taxpayers should submit online their fully completed license applications and requests for decals, along with the amount from Line 9, by visiting the Department's website at <https://tntap.tn.gov/eservices>. Alternatively, they may mail the license application and decal fees to the following address. Checks should be made out to the Tennessee Department of Revenue.

### Application

- Line 1: Complete this section with the vending machine operator's business information.
- Line 2: Enter the date your coin-operated amusement business will begin in Tennessee at the Business Location provided in Line 1.
- Line 3: Select the correct type of ownership of the coin-operated amusement machine operator.
- Line 4: For use by out-of-state businesses only. Indicate the address of any location or office within Tennessee.
- Line 5: Include the requested information for all owners, officers, members, and partners. Please attach additional sheets if needed.
- Line 6: Select the Master License option needed.
- Use these values for applicants entering business prior to January 1st.

- Enter on Line 6 the total amount of license fee that should be remitted.
- Line 7: Enter the total number of machines to be placed in use.
- Line 8: Multiple Line 7 by **\$10**. This is the total amount of decal fee that should be remitted.
- Line 9: Add Line 6 and Line 8 for the total amount due. This is the total amount due for both the license and decal fees that should be remitted to the Department of Revenue.
