Offering an alternative to this option, the new Dealer Drive-Out EZ-Tag program allows dealers to electronically submit vehicle, lien, and owner information to the county clerk’s office and quickly and easily produce a unique print-on-demand temporary plate in lieu of a controlled stock tag. Trailer manufacturers or businesses selling trailers which do not require registration: Use this form to order temporary trailer permits to provide for customers (TCA § 55-4-115(d)) . This permit allows an applicant operating a motor vehicle using a trailer that is not subject to registration in Tennessee a five-day period of operation, when the proposed operation is temporary in character.

Individuals: Use this form to purchase an individual trailer temporary plate.
